



JUNE 17, 2021 COVID-19 UPDATE

WERE ALL IN THIS TOGETHER.

NOTICE OF “ORDER OF COUNCIL” under the COVID-19 Interim Law

Chief and Council met on June 17, 2021. This order is effective immediately until further notice, and will be reviewed by Chief and Council on a regular basis based on recommendations from the Sts'ailes Officials and EOC Team:

1. The Community Gate will remain in place;
2. Visitor passes are available to off-reserve Sts'ailes Members and individuals with Sts'ailes interests who can provide proof of vaccination. Passes are now authorized for overnight stays as well as day visits.
 - a. “Sts'ailes interests” means or any persons who are not registered Members, but are related to a Member by blood, by marriage, legal adoption or custom adoption.

NOTE - If you have already provided **proof of vaccination** and have a **Lime Green Pass** those named on the pass will automatically qualify for an overnight stay

3. Sts'ailes Administration:
 - a. Sts'ailes Administration Buildings are open with safety measures in place,
 - b. Sts'ailes Daycare is open with safety measures in place,
 - c. Sts'ailes Community School remains virtual until further notice,
4. Sts'ailes Residents and visitors can participate in safe outdoor recreational groups and sporting events/activities* consisting of up to ten (10) people indoors, or up to fifty (50) people outdoors with the following Covid-19 safety rules in place:
 - a. Participants must practice social distancing and safety measures,
 - b. No sharing of meals,
 - c. Adequate means for hand sanitization and/or frequent handwashing must be provided,
 - d. Mask wearing is required indoors or when social distancing is not possible.



**Examples of safe outdoor recreational group activities include: Elder's Walking Program, Yeqwethet and Snowoyelh Programs, soccer, hockey, canoe pulling, cultural gatherings, etc.*

5. Outdoor activities consisting of more than fifty (50) people, and/or indoor activities consisting of more than ten (10) people may take place if a safety plan is submitted to Lands@stsailles.com in advance. This plan **must be reviewed and approved** by the pandemic response team for ***before the event/activity can take place***;
6. Sts'ailes Residence can have up to ten (10) people in their homes or up to fifty (50) people outdoors, if the home/property can accommodate social spacing and practice the following Covid-19 safety rules:
 - a. Participants must practice social distancing and safety measures,
 - b. Adequate means for hand sanitization and/or frequent handwashing must be provided,
 - c. Mask wearing is required indoors or when social distancing is not possible.
 - d. Open windows to create good airflow,
 - e. Sanitizing of high touch areas between visitors, Tables, chairs, countertops, doorknobs, light switches, etc.
 - f. If you are sick do not have visitors or visit other homes,

Please follow these measures for your safety and the safety of your loved ones.

This is why the law is in place, Before you breach, think.

Before you breach, ask for help.

Before you breach, consider the consequences to your health, the health of your loved ones, and other consequences:

If any person does not comply with this Order of Council is guilty of an offence and liable on conviction to a fine not exceeding one thousand (\$1,000.00) dollars, imprisonment for up to six (6) months, or both imprisonment and a fine, also jeopardizing your employment and/or tenancy agreement with Sts'ailes.

UPDATED PROCEDURES FOR VISITORS TO STS'AILES

Community Resident must register their visitors a **minimum of one business day before** the visiting date and between **8:30am and 3:30pm** (*closed between 12:00pm-1:00pm*) Monday to Friday (**NO Facebook requests will be accepted**).

 - a. Christy at 604-796-2116

2. Provide the following information:
 - a. **Must** provide vaccination records for at least one dose (and at least 21 day's post vaccination)
 - b. Must reside within British Columbia as per provincial health restrictions,
 - c. Name, phone number and email address of the resident being visited,
 - d. Name, phone number and email address of all the off-reserve visitors for contact tracing purposes,
 - e. Make, model, color, and license plate number of visiting vehicle to add to the visitor day-pass (if the visitors are entering with a vehicle).
