



MAY 10, 2021 COVID-19 UPDATE

NOTICE OF “ORDER OF COUNCIL” under the COVID-19 Interim Law

Chief and Council met on Tuesday May 4th, 2021. This order is effective immediately until further notice, and will be reviewed by Chief and Council on a regular basis based on recommendations from the Sts'ailes Officials and EOC Team:

1. The Community Gate will remain in place;
2. Day passes will be open to off-reserve Sts'ailes Members and individuals with Sts'ailes interests
 - a. “Sts'ailes interests” means or any persons who are not registered Members, but are related to a Member by blood, by marriage, legal adoption or custom adoption
 - b. Day passes are limited to one off-reserve household at a time per household.
3. Wednesday May 12th the store will be opening to the general public and the gate will be moved to the stop sign between the current gate and the pump house;
4. Sts'ailes Administration:
 - a. Sts'ailes Administration Buildings are opened with safety measures in place and visits are by appointment only,
 - b. Sts'ailes Daycare is opened with safety measures in place,
 - c. Sts'ailes Community School remains virtual until further notice,
5. Sts'ailes Residents and visitors can participate in safe outdoor recreational group activities* with the following Covid-19 safety rules in place:
 - a. Must include a safety plan, submitted to and approved by Yeqwethet;
 - b. Following social distancing and safety measures,
 - c. No sharing of meals,
 - d. Sanitizing and/or frequent handwashing,
 - e. Mask wearing, etc.,

*Examples of safe outdoor recreational group activities include: Elder's Walking Program, Yeqwethet and Snowoyelh Programs, soccer, hockey, canoe pulling, cultural gatherings, etc.



6. Sts'ailes Residence can continue to extend their core bubble/safe circle with ONE other home within Sts'ailes, for a **TOTAL** of **two** homes to gather for outdoor activities only and practicing Covid-19 safety rules:
 - a. following social distancing and safety measures,
 - b. no sharing of meals,
 - c. sanitizing and/or frequent handwashing,
 - d. mask wearing, etc.,
 - e. must stay with the same home,
 - f. **DO NOT** switch between homes;
7. Sts'ailes Elders and individuals with disabilities can continue to have family members provide essential services in their home and have family gather for outdoor activities visits. Covid-19 safety rules must be followed:
 - a. One (1) other home can be at the elder's home at a time
 - b. Remain a minimum 6 feet apart
 - c. Wear a mask when the 6 feet distance can't be maintained,
 - d. no sharing of meals,
 - e. sanitizing and/or frequent handwashing,
 - f. mask wearing,
 - g. Sanitizing of high touch areas between visitors
 - i. Washing tables, chairs, doorknobs, light switches, etc.
8. No unsanctioned gatherings, assemblies or parties of any size in the community or in your home, for example
 - a. Do not invite friends or extended family inside your home
 - b. Do not host a party or event inside your house
 - c. Do not host a party in public spaces on Sts'ailes Lands

Please follow these measures for your safety and the safety of your loved ones. This is why the law is in place. Before you breach, think. Before you breach, ask for help. Before you breach, consider the consequences to your health, the health of your loved ones, and other consequences: If any person does not comply with this Order of Council is guilty of an offence and liable on conviction to a fine not exceeding one thousand (\$1,000.00) dollars, imprisonment for up to six (6) months, or both imprisonment and a fine, also jeopardizing your employment and/or tenancy agreement with Sts'ailes.

UPDATED PROCEDURES FOR DAY VISITORS TO STS'AILES

Community Resident must register their visitors a minimum of one business day before the visiting date and between 8:30am and 3:30pm (closed between 12:00pm-1:00pm) Monday to Friday (NO Facebook requests will be accepted) by:

1. Emailing Lands@stsailles.com
2. Calling Christy at 604-796-2116 or Dawn at 604-997-7404
3. Provide the following information:
 - a. Must provide vaccination records for at least one dose (and at least 21 days post vaccination)
 - b. must reside within the Lower Mainland Health Region as per provincial health restrictions,
 - c. Name, phone number and email address of the resident being visited,
 - d. Name, phone number and email address of all the off-reserve visitors for contact tracing purposes,
 - e. Make, model, color, and license plate number of visiting vehicle to add to the visitor day-pass (if the visitors are entering with a vehicle).

Reminders:

- Each visitor will be asked COVID-19 health safety questions.
- Once the visitors are successfully registered, the list of visitors will be provided to the gate staff at the end of each day.
- Visitors registered with the vehicle are the only ones permitted to enter.
- Members who cannot produce proof of vaccination will not be granted access to Sts'ailes Lands.
- Community resident must register visitor or passes will not be granted.
- The passes are for day visits only from 7:00am to 8:00pm, no overnight stays are permitted.
